

TEMPORARY EXEMPTION REQUEST FOR PASSENGERS DUE TO RELIGIOUS BELIEF

A. Instructions for Passengers

The person requesting a temporary exemption must submit a completed copy of this form in its entirety to the carrier/operator. All pages must be reviewed and completed by the person to be exempted and/or requester, as well as by the required Commissioner of Oaths.

This exemption form must be completed in full submitted to the carrier/operator for approval prior to departure in accordance with the operator's requirements (21 days in advance). Passengers may also beasked to provide the completed exemption form any time Proof of Vaccination is required (e.g. at time of booking, at check-in, before boarding, etc.). Please consult specific carrier/operator instructions when booking your travel. Carriers/Operators will approve exemptions at their sole discretion.

In addition to any other accommodation measures that could be required by the carrier/operator, passengers with an approved temporary exemption will also need to present to the carrier/operator results of COVID-19 molecular test taken:

- Within 72 hours of the passenger's scheduled departure time, where the result is negative, or
- At least 14 days before but not more than 180 days prior to the traveler's scheduled departure time(traveler eligible to travel on day 15), where the result is positive.

In the event that any personal information is provided to Transport Canada, it will only be used and disclosed by Transport Canada in accordance with the Privacy Act and its regulations.
