Based on information referred by the Office of Competitive Market Oversight, the Bureau of Investigation and Enforcement (BIE) opened an Informal Investigation of National Gas & Electric, LLC (NG&E) to examine whether the actions of NG&E violated Commission Regulations or Orders. Based upon its Informal Investigation, BIE determined that NG&E and/or its agents engaged in slamming and engaged in fraudulent, deceptive, or otherwise unlawful acts in the process of marketing and selling electric generation supplier services. On 8/29/22, the Parties filed a Joint Petition for Approval of Settlement (Settlement Agreement) and Statements in Support of Settlement to resolve the Informal Investigation. The Settlement Agreement, *inter alia*, imposes a \$15,250 civil penalty on NG&E. By Order entered 10/27/22, the Commission directed that notice of the Order and the Settlement be published in the Pa. Bulletin for comments (October 2022 Order). On 11/12/22, the October 2022 Order and the Settlement were published in the Pa. Bulletin. No comments were filed.

On 12/28/22, the Commission entered the Opinion and Order which answered the Material Question in the affirmative and denied the Petition.
