Wording of Variations

Clause 1 Definitions and Interpretation

- 1. The following amendments are made to **clause 1.1**:
 - 1.1. The definition of "Data Protection Legislation" is substituted as follows:

"Data Protection Legislation" means "(i) the GDPR and any applicable national implementing Laws as amended from time to time (ii) the DPA 2018 to the extent that it relates to processing of personal data and privacy; (iii) all applicable Law about the processing of personal data and privacy;

1.2. Immediately after the **definition of "Dispensing Services"**, the following new definition is inserted:

""DPA 2018" means the Data Protection Act 2018;"

1.3. Immediately after the **definition of "General Medical Services Contracts Regulations",** the following new definition is inserted:

""GDPR" means the General Data Protection Regulation (Regulation (EU) 2016/679);"

1.4. The **definition of "Personal Data"** is replaced by:

""Personal Data" shall have the meaning assigned to it by the Data Protection Legislation;"

 - "85.3 The parties acknowledge that the Board and the Contractor shall be Data Controllers in respect of the Personal Data supplied by the Board to the Contractor under this Agreement."¹
- 6. Clause 85.4 is substituted as follows:
 - "85.4 Reserved"
