According to the National Institute on Drug Abuse (NIDA), new drugs and drug use trends often burst on the scene rapidly. This has been the case with the use of a dangerous synthetic cathinone drug, Alpha PVP - popularly known as "Flakka".

The nightly news continues to report Broward County's prominence of violent individuals with super strength streaking in the streets or the apparently insane paranoid person trying to break into the police department. Also known as "gravel", this very inexpensive dose of euphoria that creates excited delirium and hallucinations has been dubbed the "\$5.00 Insanity" by one of its users.

This session will provide insight of the Flakka's physical and psychological impact on the user and an understanding of the cognitive changes in users who seek treatment.

At the conclusion of this program, participants will be able to:

- ◆ Cite the epidemiology of synthetic cathinone drugs
- ◆ Discuss drug abuse trends and the loopholes that allow these drugs to continue to be legally imported into this country
- ◆ Describe the physical and psychological effects of Flakka, including long-term effects that can appear weeks and month after using Flakka
- ◆ Discuss police protocols when dealing with persons using Flakka
- ◆ Differentiate treatment modalities for Flakka
- ◆ Assist patients and families in addressing the Flakka epidemic
- ◆ Provide appropriate referrals for community resources

The Presenters

James N. Hall

Jim Hall serves as Epidemiologist with the Center for Applied Research on Substance Use and Health Disparities at Nova Southeastern University. For the past 30 years, he has tracked patterns and trends of substance abuse in Florida as the State's representative on the National Institute on Drug Abuse's (NIDA) Community Epidemiology Work Group.

Mr. Hall's work has focused on converting research about emerging drug abuse problems into community-based solutions for South Florida drug prevention coalitions. He has represented the United States at several Organization of American States conferences over the past six years and is assisting a US Government project in the development of a substance abuse epidemiology work group in Iraq.

Recipient of the 2010 Paths of Public Health Award for Epidemiology and Disease Surveillance from Florida International University, Jim also was presented a Lifetime Achievement Award by the South Florida Coalition Alliance in June 2014. He has been named to the Scientific Advisory Panel of the National Institutes of Health's (NIH) recently established National Drug Early Warning System.

Nabil El Sanadi, MD, MBA, FACEP, FACHE

Nabil El Sanadi, M.D. is the President/Chief Executive Officer (CEO) of Broward Health and a board certified emergency medicine physician. As President/CEO, he oversees all operations for one of the largest public health systems in the United States.

Prior to his appointment as President/CEO in December 2014, Dr. El Sanadi was chief of emergency medicine for Broward Health. In January of 2014, he was elected chairman of the Florida Board of Medicine. He serves as emergency medical services (EMS) medical director for several municipalities.

Dr. El Sanadi graduated with honors in medicine and public health from Ohio State University. He completed his medical residency and a one-year research fellowship at the Cleveland Clinic Foundation in Cleveland, Ohio. Dr. El Sanadi earned his bachelor's degree in chemistry with honors from Case Western Reserve University. He obtained his Master of Business Administration at the Weatherhead School of Management, and went on to complete certifications as a licensed Health Care Risk Manager and Lean Six Sigma Black Belt.

In 1994, Dr. El Sanadi joined EmCare, previously Phoenix Physicians. In the administrative role of chief of emergency medicine for Broward Health Medical Center, and then for Broward Health system, he oversaw the management of hospital practices and physicians. Prior to that, he served as chief of emergency medicine at University Hospitals of Cleveland where he directed a large teaching and research-focused emergency department. He currently holds faculty appointments at Florida International University, Nova Southeastern University and the University of Miami.

Dr. El Sanadi is a former member of the Broward Regional Health Planning council, a Fellow of the American College of Healthcare Executives (FACHE) and the American College of Emergency Physicians (FACEP) and he serves on the boards of the Broward County Medical Association (BCMA) and Florida Medical Association (FMA).

Donald Maines, MBA, CAP, CGAC, CES

Don Maines is currently the Special Advisor for Substance Abuse Research for the Broward Sheriff's Office (BSO). In addition to implementing treatment outreach for community programs, Don also developed and implemented a Mobile Equine Assisted Therapy Program.

Working in the substance abuse field for 30 years, Mr. Maines' prior experience includes Treatment Counselor for the Post Adjudicatory Drug Court Program at BSO, Therapist at the Family Institute in Ft Lauderdale, and Executive Director of the National Safety Council. In addition, he has been an Adjunct Professor at Fort Lauderdale College.

Mr. Maines has a Bachelors of Business Administration from Fort Lauderdale College and an honorary Masters of Business Administration from Florida Metropolitan University. Other training has provided him with certification in equine assisted therapy and gambling addiction and Mr. Maines is a Certified Addiction Professional (CAP) and a Certified Employee Assistance Professional (CEAP).

Active in the community, Mr. Maines continues to be on the Advisory Board for the Broward Addiction Recovery Center (BARC) and has served on other board and committees as well as serving as mayor and council member for Southwest Ranches. In recognition of his valuable contribution to the community, July 12, 2004 was proclaimed as Don Maines Appreciation Day in Broward County.
