

Payroll/Pension Medical Deductions

In the November 26, 2014 open enrollment letter sent to all active employees, the H&W Fund stated that they would review the medical spend for the first 6 months of 2015 to determine if a change would be necessary to our payroll/pension medical deductions. In July of 2015, after consulting with the Fund's Actuary, the Trustees of the Fund have voted to keep the current payroll/pension medical deductions in place for the remainder of 2015.

This decision means that the Trustees of the H&W Fund have been able to keep the payroll/pension medical deductions that were put into place in April of 2014 to December 31, 2015. The November of 2015 open enrollment letter will explain IF any changes in deductions will be needed for 2016. It is the goal of the Trustees to keep deductions as low as possible to the members of the Fund.

Please note that the next time that you come into District Council 47, located at 1606 Walnut Street, you will notice that the Health and Welfare Fund offices are now located on the First Floor. Members will now have easy access to our Health and Welfare Staff by having all of their Health and Welfare concerns taken care of without having to go on the elevator or climb the stairs! Are you or your spouse age 65 or over and RETIRED?



If YES, make sure that you apply for Medicare Part "B" and contact the Health and Welfare Fund office at 215-893-3774, 215-893-3775, or 215-893-3776 for further information.

If you are RETIRED and age 65 or over, you must enroll in Medicare Part "B" in a timely fashion or you will be penalized by Medicare. You may contact your local Social Security office for more information, or contact the Health and Welfare Fund.
