Dear Majority Leader McConnell, Speaker Ryan, Minority Leader Reid, and Democratic Leader Pelosi:

As you work to assemble a Fiscal Year 2016 omnibus funding bill, we strongly urge you to include legislation to address the lack of a state-based permit program through which the Environmental Protection Agency's (EPA) coal combustion residuals (CCR) rule – commonly referred to as the "coal ash rule" – can be implemented and enforced. A revised version of the House-passed H.R. 1734, developed with technical assistance from the Environmental Protection Agency to address concerns raised by the Administration, was filed by Representative McKinley as an amendment to the highway bill. It is that text that we urge you to include in the omnibus.

EPA's CCR rule is already in effect and our members are moving to comply with the rule. Without legislation that allows for implementation of EPA's rule by the states, however, power plant operators have no regulatory agency with whom they can work to make multi-million dollar, site-specific judgments about the application of the new federal requirements. Application of the federal requirements is normally done through issuance of a permit, a feature absent from EPA's rule, but one that would be required under the legislation. Furthermore, the only enforcement mechanism for these new federal requirements under the EPA rule is through citizen suits, an inefficient and potentially ineffective mechanism that would also be resolved under the legislation.

Regulated entities and the public deserve a fully functional permit program to ensure proper implementation and enforcement of the CCR requirements. The McKinley language accomplishes that and ensures that EPA has prior approval of each state permit program.

This has become an urgent and time-sensitive concern for our members. We appreciate that you have many competing priorities for the omnibus, but we believe that five years of bipartisan, bicameral work – and consultation with EPA on the text – makes the McKinley language ripe for inclusion. Thank you for your consideration of our request.
