#### 11 Days of Dishonored® 2 Sweepstakes

#### **OFFICIAL SWEEPSTAKES RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. **11 Days of Dishonored® 2 Sweepstakes** (the "Sweepstakes") is sponsored by Bethesda Softworks LLC (the "Sponsor").
