

Adoption of the Mid-Atlantic Regional Ocean Action Plan

The Mid-Atlantic Regional Ocean Action Plan (Plan) is the result of an historic collaboration among six Mid-Atlantic States, two federally recognized Tribes, eight Federal agencies, and the Mid-Atlantic Fishery Management Council, acting collectively as the Mid-Atlantic Regional Planning Body (Mid-A RPB) and informed by the extensive participation of stakeholders throughout the region and beyond.

The Plan describes a series of collaborative actions and best practices related to the use of data, interjurisdictional coordination, and stakeholder engagement that will inform and guide Federal, State, Tribal, and Mid-Atlantic Fishery Management Council activities under existing authorities. The companion Mid-Atlantic Ocean Data Portal (Data Portal) presents thousands of publicly available maps that represent components of the marine ecosystem and a wide range of human activities. The Plan and Data Portal promote healthy ocean ecosystems and sustainable ocean uses in Mid-Atlantic waters. The Plan imposes no new regulatory requirements.

The Plan was developed pursuant to Executive Order 13547 (July 19, 2010), "Stewardship of the Ocean, Our Coasts, and the Great Lakes." The Executive Order adopted the Final Recommendations of the Interagency Ocean Policy Task Force (Council on Environmental Quality, 2010); established the National Ocean Policy; and provided for the development of regional marine plans that build upon and improve existing Federal, State, Tribal, local, and regional decision making and planning processes.

Implementation of the Mid-Atlantic Regional Ocean Action Plan

The National Ocean Council certified that the Plan is consistent with the National Ocean Policy effective December 5, 2016. The Federal members of the MidA RPB administer a wide range of statutes and programs that involve or affect the marine environment. These Federal departments and agencies carry out actions under Federal laws involving a wide range of regulatory responsibilities and non-regulatory missions and management activities throughout the Mid-Atlantic regional ocean planning area. The specific manner and mechanism each Federal agency will use to implement the Plan will depend on that agency's mission, authorities, and activities. Each Federal MidA RPB member will use the Plan to inform and guide its planning activities and decision-making activities.

Specifically, consistent and within existing statutory authorities, Executive Order 13547 and the Final Recommendations, the Federal agencies represented on the MidA RPB hereby adopt the Plan, and will: 1) identify, develop, and make publicly available implementing instructions, such as internal agency guidance, directives, or similar organizational or administrative documents, that describe the way the agency will use the Plan to inform and guide its actions and decisions in the Mid-Atlantic ocean planning area; 2) ensure that the agency, through such internal administrative instructions, will consider the data products available from the Data Portal in its decision making and as it carries out its actions in the Mid-Atlantic ocean planning area; and 3) explain its use of the Plan and Data Portal in its decisions, activities, or planning processes that involve or affect the Mid-Atlantic regional ocean planning area.

This document does not create any right or benefit, substantive or procedural, enforceable by law or equity against any signatory or agency. This document does not substitute for or supersede any legally binding statutes or regulations. In the event of a conflict between this document and requirements under statute or regulation, the latter controls. All commitments made by agencies herein are subject to the availability of appropriated funds and agency budget priorities.

Tribal, State, and Mid-Atlantic Fishery Management Council participation in the development and implementation of the Plan is voluntary. These entities strongly value the benefits of regional collaboration and have been equal partners in the development of the Plan. By their signatures below, the Tribal and Mid-Atlantic Fishery Management Council members of the Mid-Atlantic Regional Planning Body hereby agree to adopt and assist in the implementation of the Plan. The Mid-Atlantic States support the Plan and commit to assist in its implementation as described by them in Addendum 1.

Delaware has long recognized the importance of coordination and cooperation in the management and stewardship of its coastal and ocean resources.

As a participant in the Mid-Atlantic regional ocean planning process, Delaware has contributed to and benefitted from this state, federal, and tribal initiative to collect and display regional-scale data of marine resources and ocean-based uses, the convening and engagement of diverse ocean stakeholders, and the identification of priorities and responses to regional needs. The data, information, and stakeholder input that went into the development of the Mid-Atlantic Regional Ocean Action Plan ("Plan") and the actions described in it complement and integrate well with ongoing ocean management in Delaware.

The purpose of this letter is to express Delaware's support for the Plan.

The Plan is a culmination of collaborative discussions that have occurred since 2013 and outlines a suite of actions for improving collaboration on decision making for ocean waters of the Mid-Atlantic. It represents an opportunity to work with neighboring states, federal agencies, tribes, the Mid-Atlantic Fishery Management Council and our stakeholders to collaborate on projects for our collective economic and environmental well-being. - Consider relevant regional-scale data and information referenced in the Plan and accessible from the online spatial Portal to inform project review and decision-making. Data and information in the Portal are not the exclusive nor sole source of information, and maps and data sources should be used with an understanding of the associated caveats and limitations. In most cases, finer scale, site-specific information will still be required to support regulatory review and other management and permitting actions.
- Assist with Plan performance monitoring actions including the development and/or review of a performance monitoring and evaluation framework and a proposed approach for ocean ecosystem health indicators.
- Assist with identifying the Plan's regional applied science and research priorities.

The State's support for and continued participation in matters related to the implementation or further revision of the Plan is subject to, and in accordance with, the following stipulations and conditions:

- Nothing in the Plan commits the State, now or in future, to expend, allocate, or appropriate state or federal funds or other resources that are or may become available for any purpose, including but not limited to implementation or further revision of the Plan;
- At its sole discretion, the State may terminate, revoke, or further qualify its support for the Plan as a whole, or in part, at any time;

The State of New York has long recognized the importance of coordination and cooperation in the management and stewardship of coastal and ocean resources. Beginning in 2006 with the enactment of the New York Ocean and Great Lakes Ecosystem Conservation Act; the development of the New York State Ocean Action Plan; and Governor Cuomo's recent approval of a bill to create the New York State Ocean Acidification Task Force, the State has both provided leadership and sought collaborative opportunities for action based on shared priorities identified at the local, State, and regional interstate level. As a participant in the Mid-Atlantic Regional Planning Body (Mid-A RPB), the State of New York has contributed to and benefitted from the development of the Mid-Atlantic Regional Ocean Action Plan (Plan). This letter expresses the State of New York's general support for the final Plan as approved by the National Ocean Council.

The Plan is a culmination of collaborative discussions that have occurred since 2013 and outlines actions for improving collaboration on decision making for ocean waters of the Mid-Atlantic. The planning process involved collection and display of regional-scale data of marine resources and ocean-based uses on a Mid-Atlantic Ocean Data Portal (Portal) and the engagement of diverse ocean stakeholders. New York believes that maintaining this fact-based and collaborative approach will be essential to successfully implementing the Plan's actions.

The State of New York agrees with the general approach of the Plan's actions, with the understanding that the Plan does not in any way diminish, increase, or otherwise alter the rights, duties, authorities, or sovereignty of any entity or the general public. Additionally, while the State

supports the Plan as a whole, the State's continued participation in Plan implementation is at the State's discretion, may be altered at any time, and does not commit the State to expend any funds or resources.

To focus the efforts of the RPB as it shifts to implementation, the State has identified the following as important components of the Plan that should be considered by federal agencies for early implementation.

- The coordination and consultation processes recommended in the Plan to improve interactions between federal, state and tribal entities;
- The updating of the data and maps on the Portal to keep it relevant, and consideration of relevant data and information accessible on the Portal to inform project reviews and decision-making, as appropriate and with the understanding of associated caveats;
- The development of a Mid-Atlantic Ocean Acidification Monitoring Network that dovetails with the work of New York's Ocean Acidification Task Force:
 - identifying ocean ecosystem health indicators; and
 - identifying regional applied science and research priorities.

The State looks forward to identifying opportunities to assist federal agencies with their implementation of the Plan, to the extent practicable and consistent with applicable law, with the goal of improved health and management of our ocean resources.

The Commonwealth of Virginia has long recognized the importance of coordination and cooperation in the management and stewardship of its coastal and ocean resources.

As a participant in the Mid-Atlantic regional ocean planning process, Virginia has contributed to and benefitted from this state, federal, and tribal initiative to collect and display regional-scale data of marine resources and ocean-based uses, the convening and engagement of diverse ocean stakeholders, and the identification of priorities and responses to regional needs. The data, information, and stakeholder input that went into the development of the Mid-Atlantic Regional Ocean Action Plan ("Plan") and the actions described in it complement and integrate well with ongoing ocean management in Virginia.

The purpose of this letter is to express the Commonwealth's support for the Plan.

The Plan is a culmination of collaborative discussions that have occurred since 2013 and outlines a suite of actions for improving collaboration on decision making for ocean waters of the Mid-Atlantic. It represents an opportunity to work with neighboring states, federal agencies, tribes, the Mid-Atlantic Fishery Management Council and our stakeholders to collaborate on projects for our collective economic and environmental well-being. It will also allow us to identify and protect shared resources and anticipate and resolve potential conflicts.

The Mid-Atlantic Regional Ocean Action Plan is the first-ever regional ocean action plan for the Mid-Atlantic and a major milestone. However, it is only a starting point in the realization of

improved ocean management. An on-going dialogue between state, federal, and tribal entities and our partners and stakeholders is essential to implementing many of the actions outlined in the Plan.

We recognize that this is an enormous undertaking and we look forward to being a willing and committed partner to address the commitments of the Plan, where appropriate.

Subject to, and to the extent provided by the stipulations and conditions outlined below, the Commonwealth of Virginia agrees to assist in the implementation of the Mid-Atlantic Regional Ocean Action Plan developed by the Mid-Atlantic Regional Planning Body (Mid-A RPB) pursuant to the National Ocean Policy established by Executive Order 13547, to the extent practicable and consistent with applicable law. Such implementation shall generally include:

- Participation in the coordination and consultation processes recommended in the Plan, aimed toward facilitating improved interactions between federal, state and tribal entities.
- Contributions to the implementation of actions identified and described in the Plan, such as, helping to develop and/or review updates to the data and maps on Portal; assisting with engagement of stakeholders and specific communities/sectors related to various ocean activities or issues; and participating on various future working groups that will help to move our common objectives forward.
- Consideration of relevant regional-scale data and information referenced in the Plan and
 accessible from the online spatial Mid-Atlantic Ocean Data Portal to inform project review
 and decision-making. Data and information in the Portal are not the exclusive nor sole
 source of information, and maps and data sources should be used with an understanding of
 the associated caveats and limitations. In most cases, finer scale, site-specific information
 will still be required to support regulatory review and other management and permitting
 actions.
- Assistance with Plan performance monitoring actions including the development and/or review of a performance monitoring and evaluation framework and a proposed approach for ocean ecosystem health indicators.
- Assistance with identifying the Plan's regional applied science and research priorities.

The State's support for and continued participation in matters related to the implementation or further revision of the Plan is subject to, and in accordance with, the following stipulations and conditions:

• Nothing in the Plan commits the State, now or in future, to expend, allocate, or appropriate state or federal funds or other resources that are or may become available for any purpose, including but not limited to implementation or further revision of the Plan;

- At its sole discretion, the State may terminate, revoke, or further qualify its support for the Plan as a whole, or in part, at any time;
- At its sole discretion, the State will determine the nature and extent of its participation in
 matters related to implementation or further revision of the Plan, which may depend, in part,
 on federal agencies' continuing commitment to the Plan and timely update of its data and
 information resources, and, in any event, state participation will be dependent on existing and
 available budgeted resources;
- The Plan will be interpreted and used in a manner fully consistent with the understanding that the Plan does not in any way diminish, increase, or otherwise alter the rights, duties, authorities, or sovereignty of any federal or state agency, federally-recognized Indian tribe or other governmental entity, the regulated community, or the general public under state law or federal law, including, but not limited to: the Clean Water Act, the Clean Air, Coastal Zone Management Act, Outer Continental Shelf Lands Act, Magnuson-Stevens Fisheries Conservation and Management Act, the Deepwater Port Act, the Federal Power Act, National Environmental Policy Act, or the Constitution of the United States;
- The Plan is purely advisory and nothing in the Plan commits or may be construed to commit the State to take or refrain from any action, or act or refrain from acting in any particular manner, on any matter whether or not it is specifically addressed by the Plan; and
- The Plan is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity against the State, its department, agencies, instrumentalities, officers, employees, or agents, or any other person or entity.

The Commonwealth of Virginia looks forward to working in a spirit of collaboration with the Mid-Atlantic Regional Planning Body and our partners and stakeholders throughout the region to continue our efforts to improve the health and management of the nation's ocean resources.
