



APPLYING FOR A NEXTEER STEERING THE FUTURE FUND GRANT:

THE PURPOSE:

Nexteer Automotive is a worldwide leader in developing innovative automotive steering and driveline products. Nexteer Automotive fosters a **High-Performance Culture** – one that stresses a **Sense of Urgency, Strong Relationships, Robust Dialogue** and **Clarity of Purpose**. Using these four values and their associated competencies, the global team is committed to living the High-Performance Culture in everything it does; that includes its support of the communities it serves and the communities its employees live, work & play.

Through the **Nexteer Steering the Future Fund**, Nexteer Automotive offers financial support for non-profit charitable 501(c) 3 organizations. The Nexteer Steering the Future Fund, **administered by the Saginaw Community Foundation**, is overseen by a committee of Nexteer employees who review all applications and make grant determinations based on the merits of each application and the amount of funding requested. The decisions of the committee are final.

THE CRITERIA:

- Applicant must be a non-profit charitable 501(c)3 organization.
- Applicant must have a Nexteer Project Sponsor named in support of the application. The Sponsor can be someone working for Nexteer Automotive in a permanent or contract capacity.
- The Nexteer Steering the Future Fund provides \$2,500 quarterly in the Saginaw Community. Grants vary between \$500-\$2,500.
- The applicant *must* demonstrate in the application that the request for funding meets *one or more of the following*:

 | Improves international relations or promotes international commerce
 | Promotes entrepreneurism and innovation in business
 | Creates workplaces, communities & economies with greater diversity in ethnicity, national origin, gender, skill sets and thought
 | Improves communication skills in home, school, workplace, civic and global settings
 | Trains the next generation of industry leaders by improving business, math, engineering and technology education
 | Fosters innovation in technology and transportation
 | Improves the economies and quality of life in the communities of Nexteer's facilities and customers
 | Creates a cleaner, safer environment for future generations
- The Nexteer Steering the Future Fund will not provide funding for the following: operating budgets, previously incurred debt, basic municipal and educational services, sectarian religious programs, and/or sports team sponsorships.

APPLICATION PROCEDURE:

First, **contact the Saginaw Community Foundation** office at (989) 755-0545 to inform staff you are interested in applying Nexteer Steering the Future Fund grant. At that time, they will perform a preliminary screening over the phone to ensure the organization and project fit the eligibility requirements. Once eligibility is established, a grant **proposal number** will be issued and an editable **Nexteer Steering the Future Fund Grant Application will be emailed**. Completed applications must include the signature of an authorized representative of the non-profit applicant.

The Nexteer Steering the Future Fund meets quarterly to review applications. Application due dates are **March 1st**, **June 1st**, **September 1st** & **December 1st**. Completed applications can be **submitted to the Saginaw Community Foundation** one of the following ways:

- *Email* to <u>Kendra@SaginawFoundation.org</u> at the Saginaw Community Foundation no later than 11:59 pm on the application due date (preferred method);
- *Mail* to the Saginaw Community Foundation at 1 Tuscola, Suite 100B, Saginaw, MI 48607. Note: Mail must be postmarked no later than the application due date or it will not be considered for review until the next review cycle; or
- Fax to the Saginaw Community Foundation at (989) 755-6524 no later than 11:59 pm on the application due date (least preferred).

Once received, Foundation staff will review the application, contact you if elements are missing, and then relay the information to the Nexteer Steering the Future Fund committee. All disbursements come from the Saginaw Community Foundation. Notification regarding application outcome occurs within approximately 4 weeks of the due date.

FINAL REPORT:

All organizations receiving funds from the Nexteer Steering the Future Fund must file a **post-project report** demonstrating the results of the project within six months of project completion. When possible, pictures demonstrating project results are requested. Failure to file a post-project report can result in the funds being rescinded.

- Review information on page 1 for criteria.
- Contact SCF to discuss proposal, obtain a grant proposal number, and receive an editable grant application.
- Nexteer Steering the Future Fund grant applications are due quarterly: March 1, June 1, September 1, December 1.
- Submit completed application electronically to <u>Kendra@saginawfoundation.org</u> (preferred method), by US Mail postmarked by the due date, OR by fax at (989) 755-6524.
